# Why You Should Re-elect Ed Lane

## 1. PUBLIC SAFETY

Ed Lane consistently voted to fairly compensate city employees and public safety workers – police, firefighters, and correctional officers.

## 2. PDRs AND IN-FILL

Ed Lane voted to fund PDR (to protect prime farmland) and in-fill incentives (to redevelop property within the urban service area).

## 3. ECONOMIC DEVELOPMENT

Ed Lane supports increased funding for Commerce Lexington – Central Kentucky’s economic development agency. Ed strongly advocates promoting agribusiness, technology, and economic development in the Bluegrass region.

## 4. RAINY-DAY FUND

Ed Lane voted to increase the amount saved in the “rainy-day” cash reserve fund. Ed successfully opposed a proposal taking half of the money out of the city’s “rainy day” fund and spending it in the FY07 budget.

## 5. NO WATER COMPANY TAKEOVER

Ed Lane will vote “no” on the November 7th water referendum authorizing local government to re-institute the takeover of Kentucky American Water. Ed Lane voted to end the city’s forcible takeover and condemnation of KAWC. He believes there is no justification for local government to condemn a well run, taxpaying, private business.

## 6. SMALLER GOVERNMENT

Ed Lane advocates reducing the size of local government – by outsourcing, reorganizing for better efficiency, and reducing taxes when possible. Smaller government is better government.

## 7. FINANCIAL ACCOUNTABILITY

Ed Lane voted to purchase a new accounting system that will provide much needed transparency and management control of expenditures made by Lexington’s city government.
